June: Monthly statistics

The number of customers at Avanza has during 2021 increased by 237,900, amounting to 20,000 new customers in June. This resulted in 1,518,200 customers at the end of the month. Net inflow in June was SEK 5,280m*, amounting to SEK 53,500m* during 2021.
