July: Monthly statistics

The number of customers at Avanza has during 2021 increased by 262,600, amounting to 24,700 new customers in July. This resulted in 1,543,000 customers at the end of the month. Net inflow in July was SEK 7,250m*, amounting to SEK 60,700m* during 2021.
